Pursuant to Arizona Revised Statutes § 46-803, the Arizona Department of Economic Security (ADES) submits the semiannual report on Child Care Assistance Applications.

Between December 1, 2022, and May 31, 2023, ADES received 10,200 applications for child care assistance and denied one application due to the applicants failing to provide the necessary documentation to meet the criteria for citizenship or legal residency.

# **EXECUTIVE SUMMARY**

# General nature of the document (essential information – issue/purpose/background)

Twice a year, based on statutory requirement, the Arizona Department of Economic Security (Department) is required to provide the Joint Legislative Budget Committee (JLBC) information on the number of applications received for child care services and the number of applications denied due to the application not meeting citizenship/legal residency requirements as outlined in Arizona Revised Statutes § 46-803.

### Key findings/decisions that need to be made (if any):

The Child Care and Development Block Grant Reauthorization Act of 2014 law and final rules (effective November 2016) requires lead agencies to ensure that eligible children are citizens and prohibits lead agencies from considering the parent's citizenship and legal residence status.

Beginning September 1, 2019, the Department utilizes the Employment Eligibility Verification laws for Arizona to satisfy the State citizenship and legal residence requirements for the parents applying for child care assistance.

Since the current child care eligibility process requires eligible work activities for most populations receiving child care, the Division of Child Care leverages the required documentation provided to employers to legally work as proof that the adults have satisfied the State requirement.
